Contest Entry Instructions

Deadline to receive entry forms: March 5, 2012

Fee is \$10.00 per judged entry. There is no fee for non-judged categories or youth, but entries are limited to space available. Open to all. Those under 18 must enter Youth Category. Entries must be available from Monday, March 26, 2012 through Sunday, April 1, 2012.

A cash prize will be awarded for Best in Show and First and Second Place in all categories except Youth, & non-judged entries. Additional cash awards, merchandise or certificates may be awarded at the QuiltFest committee's discretion.

- **All works must have been completed since 2008 and not exhibited previously at QuiltFest.**
- **Group entries are accepted but the entrant must have worked on the item; it is appropriate to credit the work of others, pattern sources or teachers if entry is a class project.**

• **Size:** Quilt frames are 96" x 96". If your quilt is longer, either attach a second sleeve at that height or we will fold under at the bottom. If it is wider we will try to accommodate the size with a wider hanging bar.

• **Sleeve:** All quilt entries 45" and over must have a 3 inch hanging sleeve securely affixed to the top back for hanging. If you need directions, please ask for our instruction sheet. If your quilt does not have a hanging sleeve, we will not be able to display it and it will be returned to you.

• **Identification:** All entries must have your name, address, and complete contact information affixed securely.

• **Acceptance:** Consider your entry accepted to the show or competition unless you hear otherwise.

• **Insurance:** You must provide your own insurance coverage. Whereas due care will be taken to protect your items, OCHS cannot accept responsibility for any damage.

• **Youth Category** is open to anyone under the age of 18. No cash prize will be offered in this category.

• **Drop off:** Entries should be delivered to Ohio County Historical Society

between March 19 and March 26, 2012. The **LAST DAY** to deliver entries is **Monday, March 26th**. Hours are 11 am- 4 pm seven days a week. If in doubt, call the museum at 812-438-4915

• **Pick up:** Entries will be available for pick up at the museum beginning Monday, April 2 (see hours above) or you may pick up your item at the show on Sunday **AFTER 4:30 pm**. You must sign the loan document you filled out when your entry was delivered. If someone OTHER than the person who signed the original document is to pick the entry up, they must have a signed authorization from that person. Your critique sheets will also be given to you at this time.

• **Packaging:** If you wish to have your packaging returned, please clearly mark it with your name and address. If items need to be mailed to you, proper packaging and sufficient postage must be included.

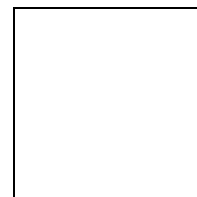
• **Display Supports:** If your quilt, wearable, art object, doll or bear entry require special support to display properly or attractively, please include that support when you deliver your entry.
